Crow Law and Order Code ("CLOC") §3-7-702 requires that the Crow Bar Exam: "... shall be administered twice each year during the second week in January and the second week in July by the Appellate Court of the Apsaalooke (Crow) Tribe." However, due to the recent surge in COVID-19 cases, and to protect the health and safety of the citizens of the Apsaalooke Nation, it was not considered prudent to administer the January 2021 Bar Exam on January 15, 2021, as set forth in the CLOC.

Therefore, pursuant to this Court's authority under CLOC § 3-3-308(4), the January 2021 examination will now be administered on Friday, February 5, 2021, at 9:00 a.m. in the Crow Tribal Court Building located at 409 Makawasha Lane, Crow Agency, Montana 59022.

Applications for the examination will be available at the Office of the Clerk of the Crow Tribal Court at 9:00 a.m. on Monday, January 11, 2021. Applications for the examination must be completed and submitted to the Office of the Clerk of the Crow Tribal Court no later than 9:00 a.m. on Friday, January 22, 2021. Registration for the examination will require a \$100.00 administrative fee that must be paid when the examination application is submitted to the Office of the Clerk of the Tribal Court.

A bar review course will also be offered on Friday, January 29 2021, between 9:30a.m. and 1:30 p.m., at the Crow Tribal Court, located at 409 Makawasha Lane, Crow Agency,

ORDER OF CONTINUANCE RE JANUARY 2021 CROW BAR EXAM Montana, 59022, or remotely. Depending on the COVID-19 situation in January 2021, this Order may be extended.

This Order of Continuance shall not be cited as precedent in any other matter.
