**AMENDED  
ORDER OF  
CONTINUANCE**

This Order amends that Order of Continuance dated January 20, 2020.

Crow Law and Order Code (“CLOC”) §3-7-702 requires that the Crow Bar Exam: “. . . shall be administered twice each year during the second week in January and the second week in July by the Appellate Court of the Apsaalooke (Crow) Tribe.” However, it was not feasible to administer the Crow Bar Exam on January 10, 2020, as set forth in the CLOC. Further, that Order of Continuance dated January 20, 2020, would have made it difficult for Crow Bar Exam applicants to timely apply.

Therefore, pursuant to this Court’s authority under CLOC § 3-3-308(4), the January 2020 examination will now be administered on Friday, February 28, 2020, at 9:00 a.m. in the Crow Tribal Court Building located at 409 Makawasha Lane, Crow Agency, Montana, 59022.

Applications for the examination will be available at the Office of the Clerk of the Crow Tribal Court at 9:00 a.m. on Friday, January 31, 2020. Applications for the examination must be completed and submitted to the Office of the Clerk of the Crow Tribal Court no later than 9:00 a.m. on Friday, February 14, 2020. Registration for the examination will require a \$100.00 administrative fee that must be paid when the examination application is submitted to the Office of the Clerk of the Tribal Court.
