Crow Law and Order Code (“CLOC”) §3-7-702 requires that the Crow Bar Exam: “. . . shall be administered twice each year during the second week in January and the second week in July by the Appellate Court of the Apsaalooke (Crow) Tribe.” However, it appears that it will not be feasible to administer the Crow Bar Exam on July 16, 2021, as set forth in the CLOC.

Therefore, pursuant to this Court’s authority under CLOC § 3-3-308(4), the July 2021 examination will be administered on Friday, July 23, 2021, at 9:00 a.m. in the Crow Tribal Court Building located at 409 Makawasha Lane, Crow Agency, Montana, 59022.


Applications for the examination will be available at the Office of the Clerk of the Crow Tribal Court at 9:00 a.m. on Friday, July 9, 2021. Applications for the examination must be completed and submitted to the Office of the Clerk of the Crow Tribal Court no later than 9:00 a.m. on Friday, July 16, 2021. Registration for the examination will require a \$100.00 administrative fee that must be paid when the examination application is submitted to the Office of the Clerk of the Tribal Court.

A bar review course will also be offered on Friday, July 16, 2021, between 9:30 a.m. and 1:30 p.m., at the Crow Tribal Court, located at 409 Makawasha Lane, Crow Agency, Montana, 59022.


