**ROCKY MOUNTAIN DETENTION CENTER
STAFF AND BIA OFFICERS**

This Court, having reviewed the options, in conjunction with detention command staff, Law Enforcement, and the Crow Tribe Office of Prosecution for the periods of celebration during the calendar year 2024, the following shall be the policy of the Crow Tribal Court:

IT IS HEREBY ORDERED:

1. That for Defendants who are arrested for the offenses of:
 - a. **Possession of Intoxicants**, in violation of 8B-8-112, CLOC.
 - b. **Disorderly Conduct**, in violation of 8B-8-101, CLOC.
 - c. **Public Nuisance**, in violation of 8B-8-110, CLOC.
2. The Defendant shall be held until they submit a BrAC of 0.00.
3. Once they can submit a BrAC of 0.00
 - a. The Defendant will be prosecuted as follows:
 - i. Friday, August 16, for offenses committed on August 15.
 - ii. Saturday, August 17, for offenses committed on August 16.
 - iii. Sunday, August 18, for offenses committed on August 17.
 - iv. Monday, August 19, for offenses committed on August 18.
 - b. **The fine for POI, DC, and PN offenses will remain at the standard of twenty-five dollars. However, if the Defendant submits a BrAC of 0.00 and wishes to be released before arraignment, a Money Order for \$25.00 per offense can be released.**
4. **Persons Under the Influence (DUI), in violation of 8C-3-302, CLOC**
 - a. Defendant will be held until they can submit a BrAC of 0.00, at which point the Defendant will be prosecuted as follows:
 - i. Friday, August 16, for offenses committed on August 15.
 - ii. Saturday, August 17, for offenses committed on August 16.
 - iii. Sunday, August 18, for offenses committed on August 17.
 - iv. Monday, August 19, for offenses committed on August 18.
 - b. **The fine for DUI offenses will remain at the standard of one hundred and eighty (\$180.00) dollars. However, if the Defendant submits a BrAC of 0.00 and wishes to be released before arraignment, a Money Order for \$180.00 can be released.**
5. The fine for these offenses during this period will be twenty-five (25.00) dollars, payable by money order ONLY to the Crow Tribal Court. This fine is per offense, not per occurrence.
6. **Tribal Court will be OPEN; Arraignments: Criminal 10 am daily, Juvenile 11 am daily.**
